3.	Read and Approve Previous Meeting Minutes	<ul style="list-style-type: none">Prior minutes reviewed as summarized by staff.Motion: James to approve. Second: Jacob. Outcome: Approved.
4.	Advisory Committee Business	<p>Protective Supervision (PS)</p> <ul style="list-style-type: none">Claudia Rodriguez stated there is no directive to reduce PS hours or PS approvals.PS is the highest level of IHSS service, up to 283 hours per month,Ventura County PS case share is comparable to Kern and Santa Barbara counties and to statewide proportions.Average authorized PS hours per recipient have held near 180 hours in recent years while recipient counts have grown. <p>Follow-up data from CDSS (received after meeting): IHSS leadership provided county-level PS statistics from the California Department of Social Services IHSS Program Data site.</p> <ul style="list-style-type: none">Table 1) As of June 2025, 1,271 of Ventura County's 10,617 IHSS recipients receive PS, which is 11.9 percent. Approximately half are minors at 648, which is 50.9 percent of PS recipients.Table 2) Average PS hours per recipient have remained near 180 hours over the past six years while the number of recipients rose from 765 in January 2019 to 1,271 in June 2025. <p>See Appendix A for full tables.
