**SUBJECT:** Discuss and File Report of Investments for the Month Ending September 30, 2010, Including Market Values for Investments for the Month

**RECOMMENDATION:** Discuss and File

**FISCAL/MANDATES IMPACT:** None

**DISCUSSION:**

The average daily portfolio balance for the month of September amounted to \$1.7 billion. The portfolio yield for the month of September was 1.38%. The weighted average days to maturity increased 5 days to 328 days. The total net monthly earnings were \$2 million. The portfolio has been structured to satisfy the anticipated cash flow needs of the participants. The investment practices and portfolio holdings are in compliance with the investment policy.

The portfolio has been managed with the stated objectives of safety, liquidity and earning a competitive rate of return, outlined in the Statement of Investment Policy. In striving to maintain the primary objective, safety of principal, the County portfolio has received a rating of AA Af by Standard & Poor's, the highest possible ranking given by the agency. Regarding the secondary objective, maintaining sufficient liquidity to meet cash flow needs, the portfolio is rated S1+, also the highest ranking given by S&P. In light of the first two objectives, the portfolio has on balance outperformed its benchmarks, satisfying the final objective, that of earning a competitive rate of return.

The economy continued to show signs of faltering during the month. Reports released during the month showed that the economy was struggling due to a weak employment environment and slow growth. The Federal Reserve's Federal Open Market Committee (FOMC), the Fed's policy-making body, met in September and voted to keep the Federal Funds rate at the existing range of 0.0% to 0.25%. The FOMC provided this justification for the decision:

*Information received...indicates that the pace of recovery in output and employment has slowed in recent months. Household spending is increasing gradually, but remains constrained by high unemployment, modest income growth, lower housing wealth, and tight credit. Business spending on equipment and software is rising,*

*though less rapidly than earlier in the year, while investment in nonresidential structures continues to be weak. Employers remain reluctant to add to payrolls. Housing starts are at a depressed level. Bank lending has continued to contract, but at a reduced rate in recent months. The Committee anticipates a gradual return to higher levels of resource utilization in a context of price stability, although the pace of economic recovery is likely to be modest in the near term.*

While the outlook continues to be disappointing, it is important to note that there is growth in the economy, though at growth rates lower than what we had been experiencing for the last 10 years. Some of this is born out in the Beige Book, the report issued by the Fed reflecting economic activity across the country. In the report, the Fed made these observations of current conditions:

- *Consumer spending appeared to increase despite continued consumer caution*
- *Activity in travel and tourism picked up*
- *Activity for professional and nonfinancial services was stable to up*
- *Manufacturing activity pointed to further expansion, though the pace of growth eased*
- *Agricultural and natural resource producers reported continued gains*
- *Home sales slowed further*
- *Demand for commercial real estate remained quite weak but showed signs of stabilization*

Interest rates were modestly lower during the month. This was largely due to the weak economic data reported and the possibility that the Fed may have to reenter the capital markets as a large buyer of securities in order to inject more liquidity. As a consequence, interest rates were 0 to 15 basis points lower and might have dropped more but for the fact that rates are already at very low levels across the yield curve.

Given the current interest rate environment, we anticipate the County's yield to drop slightly. Further, we continue to seek investment opportunities in order to optimize earnings (U. S. Treasury Market graph attached).

Attached is a listing of market values provided by our custodian, Wells Fargo Bank, for all investments for the month ending September 30, 2010. GASB Statement No. 31 states that variances between the cost of investments and the fair value of investments shall not be considered budgetary resources or uses of resources unless the value of investments is permanently impaired because of decreased issuer creditworthiness or it is determined that the Treasurer be unable to hold investments to maturity. 




# PORTFOLIO AVERAGE MONTHLY BALANCE




# AVERAGE MATURITY




