<u>STEP ONE:</u> Proceed to https://taxpayment.venturacounty.gov/webtaxonline/index.html and search for your property by parcel number or address and click "SUBMIT SEARCH" When searching by parcel number do not included dashes.






STEP FOUR: After you have added the installment(s) you wish to pay. Click "Check Out" to proceed

You will see the charge page that includes the tax payment amount, the electronic check service fee of \$1.50, and the total. Click Continue again.




