## How to Pay Your Property Tax Online Via Electronic Check A Step-by-Step Guide

**STEP ONE:** Proceed to <https://taxpayment.venturacounty.gov/webtaxonline/index.html> and search for your property by parcel number or address and click **"SUBMIT SEARCH"** When searching by parcel number do not include dashes.

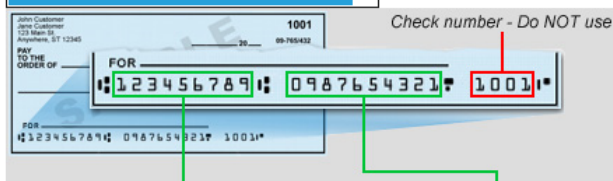
